

PRIVACY POLICY

Dear user,

by using our website (hereinafter referred to as the Website), you give your consent to the provisions of this privacy policy, which is governed by the legislation of the Republic of Armenia.

"Nika" Charitable Foundation for Infrastructure Development (hereinafter referred to as the Foundation) respects the privacy of any information about you and takes all measures to protect the privacy of your information. This statement addresses both information provided by visitors to the Site and how the Foundation handles that information.

Personal data collected through the website is used only for the purposes of the Foundation, is processed in compliance with the provisions of the legislation and is not sold. If certain information is requested from you for your identification while using the website, you can be sure that it will be used exclusively in the manner defined by this privacy policy.

The Foundation does not require visitors to the Website to register, provide personal information or create a personal page in order to view the Website or use the functional fields of the Website; it is public. You do not have to provide any personal information about you. We do not monitor or collect any personally identifiable information about you when you use the Site in this way.

How does the Site collect information about you?

Passive data collection

The Site collects certain information from you and tracks your use of our Site through specific automated technologies designed to collect and track information, such as cookies or log steps. The mentioned technological means make it possible to track how many people use the Website, but your identity is not revealed as a result of such actions. These technologies enable you to register your computer/mobile device

location for Internet system administration and troubleshooting purposes, and to record general information. To the cookie A cookie is a small piece of data that is stored on your computer's hard drive on when you visit the Site. The Foundation does not use cookies to collect personal information, but solely to track the movement of donations through the Site. Many browsers have a function to disable/block cookies, however, by visiting the Site without disabling them, you will be able to improve the Site's usability.

Active Data Collection (Provided by You)

There are cases when the Website collects data that you provide to the Foundation by noting it on the Website. Such are the cases **Donations through the Site**. In order for the Site to be able to accept and process your donation, it requests the necessary information. In particular, you fill in your name, surname, e-mail address. address, message (if desired). The data filled by you for the purpose of donation are not visible on the Website. To make the payment, your bank card number is also filled through the Website. If you choose to remain anonymous, your name remains hidden from public channels of activity, but not from the primary recipient of the transfer.

By selecting "**monthly support**": You give your consent that the amount specified by you will be debited monthly from the bank account you specified without your additional consent for each charge. This is considered as a payment order issued by you to the bank servicing your account for

the monthly collection of the amount specified by you from your bank account and transfer to the bank account of the Fund, which in turn will use these funds to fulfill the objectives of the Fund.

Donations made through the website are serviced **Ameria the bank**, which you will see a note about when making a donation. Payment: security measures are used during processing and the information provided remains unknown to us; its privacy is governed by the privacy terms and policies of that platform.

How do we use information about you?

We use the data collected by us exclusively for the following purposes:

- to ensure the most effective delivery of our website materials, taking into account the peculiarities of your browser and computer;
- public awareness, collecting statistical data about the use of our website;
- collecting statistical data on the geographical distribution of donors,
- to ensure accountability of donations and to post them in the Site's awareness windows.

Who can we disclose your data to?

We may disclose the personal information we collect and/or you provide to staff members, parties serving the Foundation under a service contract. We can also provide your data to the institutions defined by the Law only in the cases and in the order defined by the law. We may also disclose aggregate information about our visitors and donors, as well as information that does not identify any individual or entity, without limitation. We will not disclose any of your personal information other than as described above.

Data security

We take technical and organizational measures to protect the personal information we receive from loss, misuse, unauthorized modification, and to protect its privacy. We regularly review our security procedures and deploy appropriate new security technologies. We also use modern means of data transfer encryption. Unfortunately, the transmission of information via the Internet or mobile telecommunications platforms

not completely safe. Because we cannot guarantee the complete security of these encryption technologies, please use caution when sharing personal information online.

The Site may contain links that allow you to easily visit other Sites. However, once you leave the Site via those links, please note that we do not exercise any control over those other sites. Therefore, the Foundation cannot be responsible for the protection and privacy of information that you provide to other websites that are not governed by this privacy policy.
